

Terms and Conditions

The Competition

1. Entrants must create a short film lasting no longer than 2 minutes (120 seconds) on 'rocking out with your mo or your mo bros'. Participants can submit as many entries as they like. By entering the competition, Entrants agree to be bound by these terms and conditions.
2. The competition is open to Movember 'Mo Bros and Mo Sistas' registered in the United Kingdom (as defined on the Movember website: www.movember.com) except for those employed by the Movember Foundation or Marshall Amplification.
3. To enter you must upload your film to a video hosting website, such as YouTube, and the link to the video, together with the name, e-mail address, telephone number and Movember registration number of the creator must be sent to marshallcomp@movember.com. You will receive a receipt for your video entry.
4. Entrants may enter in teams. Please provide only one person's contact details per entry. Prizes cannot be expanded to the number of entrants.

6. The competition closes at 17:00 GMT on 3rd December 2010; entries received by Movember after this time and date will not be considered for the competition.
7. The winner will be notified by phone on Friday 10th December 2010.

The Film

9. You are responsible for the content of your film.
10. Films must comply with the YouTube Terms of Use (<http://www.youtube.com/t/terms>) (including any relevant privacy policies and copyright notices) and/or the terms of any other website used to upload your film.
11. Films must not contain material that is unlawful or otherwise in violation of applicable federal, state, provincial or local laws. Your film must not be discriminatory, harassing, defamatory, libellous, abusive, threatening, harmful, sexual, vulgar, obscene, or otherwise objectionable. Judges may in their absolute discretion exclude films considered to be so from the competition.
12. Films must be original works. Entrants must not submit other people's material. Your film must not infringe any copyright, trademark, logo or mark that identifies a brand or other proprietary right of any person living or deceased (including but not limited to rights of privacy or publicity or portrayal in a false light) or entity.
